Abstract

The Broken Handle Mining Corporation operated over about 800 acres near the Continenal Divide in western Clear Creek County, Colorado. The Corporation owned the rights to 34 claims and conducted precious metal mining for decades. Today, the Corporation is no longer operational, but the Hidee Gold Mine, which provides educational tours, can be seen as the Corporation's successor.

The archives of the Broken Handle Mining Corporation span 32 years and are divided into four categories: Financial Records, Corporate Data, Mining Information, and Personnel Records. Financial Records includes audits, insurance and tax records, budget estimates, financial and bank statements, attorney bills, investment records, annual shareholder reports, and income tax returns. Corporate Data includes CPA correspondence, personal property declaration documents, records of meetings with an economic analyst, minutes of annual shareholders meetings and quarterly board meetings, and other correspondence. Mining Information includes records relating to mining costs, ore reports, mapping, mining claims, reclamation, property taxes, and permits. Personnel Records includes payroll and employee records, and workmens compensation and unemployment documents.
